# 1. Introduction



Québec is a province in eastern Canada with an estimated population of 8,848,020 (2023). Its territory spans 1,667,441 km<sup>2</sup>. Québec and the province of Ontario make up central Canada. Québec is the largest of Canada's 10 provinces in area, and the second largest in population size. The province is bordered by the Hudson Strait and Ungava Bay to the north; Newfoundland, Labrador, and New Brunswick to the east; Ontario, James Bay, and Hudson Bay to the west; and Maine, Hampshire, Vermont, and New York to the south. Like other Canadian provinces, Québec is a constitutional monarchy and parliamentary democracy, with Manon Jeannotte as the Lieutenant Governor (head of state) since January 2024 and Francios Legault as the Premier (head of government). Québec City, a UNESCO world heritage centre, is the provincial capital, while Montréal is the province's major metropolis. (Source: Government of Québec, 2024).

#### 2. Economic Overview




Figure 1: Québec's real GDP and economic growth, 2014-2023

Figure 1 presents Québec's gross domestic product (GDP) in real terms between 2014 and 2023. In 2023, Québec's real GDP increased by 0.63% y-o-y, from C\$434.50bn in 2022 to C\$437.23bn in 2023. The province ranked second in Canada with regard to the size of GDP.

Highlights of Québec's key industries are provided below (Investissement Québec, 2023):

**Aerospace:** Québec ranks among the world's best in the aerospace industry. It is home to major international companies such as Bell Helicopter Textron, Bombardier Aerospace, CAE, Pratt & Whitney Canada, including equipment manufacturers and network of suppliers and subcontractors. Some 50% of the Canadian aerospace production comes from Québec, which was responsible for sales of C\$15.3 billion in 2018. Most (80%) of what is produced in Québec is exported, with the aerospace industry ranking top among Québec's manufacturing exports.

**Agri-food:** The agri-food industry is a major contributor to Québec's economy. In 2017, Québec's agricultural sector exported goods valued at C\$8.8 billion from 2,400 businesses which employed 70,000 workers. The province's main agricultural products are dairy products and meats, which accounted for almost 42% of total shipments.

**Aluminium**: Québec's aluminium industry has existed for more than a century. With an annual production of 3.2 million metric tons, Canada is the fourth-largest producer of primary aluminium in the world. Nearly 90% of Canadian aluminium is produced in Québec. The sector is the second largest sector in Québec after aerospace. With an export value of C\$7.1 billion, the aluminium industry represents 10% of the province's export market and 5% of all manufacturing shipments. The aluminium produced in Québec is the greenest in the world as more than 97% of all the energy produced in Québec is renewable and almost entirely hydroelectric.

**Mining:** Québec is vast: its total area is 1.7 million km<sup>2</sup>, of which only 1% is currently mined and 5% is covered by mining rights. Approximately one fifth of Canada's mining output comes from Québec. In addition, Québec is one of the few producers of niobium, titanium dioxide, cobalt, and platinum in the world. The province is also Canada's biggest producer of iron concentrate and zinc, and its second largest producer of gold. In addition, Its subsurface has immense potential for the extraction of materials like graphite, lithium, diamonds, rare earths, and tantalum.

**Multimedia:** Québec has spawned pioneers like Softimage and Autodesk, in addition to independents like Behaviour, Frima Studio and Sarbakan. Several industry leaders, including Ubisoft, Electronic Arts, Square Enix (Eidos), Activision (Beenox) and Warner, have propelled the industry's growth. Montréal is the world's fifth-largest video game centre, after Tokyo, London, San Francisco, and Austin.

Life sciences: Québec is a major North American centre for the life sciences industry with more than 450 companies engaged in basic research, manufacturing, biotechnology, contract research and medical technology.


They employ over 25,400 skilled workers. International companies such as Pfizer, Sanofi and Merck have chosen Québec as the site for their Canadian headquarters.

**Information and Communication Technologies (ICT)**: The Québec ICT industry has 7,500 companies, employing 210,000 workers. Nearly half of the workers are employed by ICT-centred businesses in fields like software development, microelectronics, multimedia, optics-photonics, consulting services, telecommunications, cloud computing services and artificial intelligence. As a major player in North America's ICT industry and a neighbour to the United States, Québec has access to an enormous market with close to 500 million consumers. Montréal has become known as a global hub for artificial intelligence (AI) research and its AI ecosystem is thriving.

Land transport: The land transportation industry in Québec comprises some 620 companies with over 32,000 workers, innovation research centres and many global leaders in transportation like Bombardier Recreational Products and Nova Bus. Ground transportation companies in Québec operate in a wide variety of fields, including commercial vehicles, recreational and specialty vehicles, automobiles, rail transportation and electric mobility.

As shown in Figure 2, manufacturing was Québec's top performing sector in terms of contribution (13.52%) to gross value added (GVA) in 2023. In second and third positions were real estate, and rental and leasing (with a contribution of 10.79%); and health care and social assistance (8.75%).

### 3. Trade

#### 3.1 Québec's Global Trade in Goods

Figure 3 presents Québec's global trade in goods between 2014 and 2023. In 2023, the province's global exports increased by 4.48% y-o-y to a value of C\$116.01bn from C\$111.04bn earned in 2022. On the other hand, imports decreased by 2.3% y-o-y to a value of C\$104.18bn from a cost of C\$106.71bn incurred in 2022. The province's trade balance remained in surplus at a value of C\$11.83bn in 2023, up from C\$4.33bn in 2022.

#### Key trade markets

In terms of key export markets, as shown in Table 2, the United States was Québec's top export market in 2023, with Québec's exports to the United States reaching a value of C\$87.21bn. This was equivalent to 75.17% of all export receipts earned by the province in that year. China followed in second place, with exports reaching a total value of C\$4.07bn (representing a share of 3.51%), while France placed third with exports to this nation reaching a total value of C\$1.90bn (1.64%). South Africa was Québec's 49<sup>th</sup> largest destination market for exports in 2023, with goods to the value of C\$0.11bn (or C\$108.07m) exported to the country in that year.

The United States was also the leading source market for Québec's imports, at a cost C\$34.26bn, in 2023. This was equivalent to 32.88% of all import costs incurred by the province in 2023. China followed in second place with imports reaching a total cost of C\$12.11bn (11.62%). Germany was the third largest import source market, with imports from the country valued at C\$5.60bn (5.38%) in 2023. South Africa was Québec's 34<sup>th</sup> largest import source market in 2023, at a cost of C\$0.39bn (or C\$393.62m).

### Key trade products

Table 3 shows that aircraft was Québec's dominant export category to the world in 2023. Valued at C\$6.78bn, this was equivalent to 5.84% of all export receipts earned by the province in 2023. Aluminium unwrought (not alloyed) placed second at a value of C\$5.46bn (4.70%), followed by iron ores and concentrates, at a value of C\$427bn (3.68%).

Crude petroleum oils dominated Québec's imports in 2023 which at a cost of C\$4.71bn was equivalent to 4.53% of all import costs incurred by the Canadian province in 2023. Parts of turbo-jets or turbo-propellers placed second at a cost of C\$3.87bn (or 3.71%), while parts of aeroplanes, helicopters or unmanned aircraft placed third at a cost of C\$3.45bn (or 3.31%).



#### 3.2 Québec's Trade with South Africa

Québec is generally a net importer in respect of its trade with South Africa, as can be seen in Figure 4. In 2023, the Canadian province exported goods to the value of C\$108.07m to South Africa, while its imports from South Africa amounted to a cost of C\$393.62m. Québec's exports to South Africa decreased by 6.89% y-o-y from 2022 to 2023, whereas imports increased by 12.60% y-o-y over the same period. Québec's exports to South Africa grew at an average annual rate of 6.36% over the period 2019–2023, while imports increased at a faster average annual rate of 13.68%. The net effect was a widening of the shortfall in the province's goods trade with South Africa, from a value of -C\$208.81m in 2014 to -C\$285.54m by 2023.

Helicopters was Québec's dominant export to South Africa in 2023. At a value of C\$11.39m, this was equivalent to 10.54% of all export receipts earned by the province from trade with South Africa in 2023. Ferro-niobium placed second at a value of C\$8.89m (8.23%), followed by repairs at C\$6.89m (6.38%). These figures can be observed in Table 4.

Nickel ores and concentrates dominated Québec's imports from South Africa in 2023, at a cost of C\$69.64m. This was equivalent to 17.69% of all import costs incurred by the province from trade with South Africa in 2023. Oranges place second at a cost of C\$24.23m (6.16%), while imports of vanadium oxides and hydroxides were in third position at a cost of C\$23.28m (5.91%).

## 4. Foreign Direct Investment

#### 4.1 Foreign Direct Investment from Québec in South Africa

Between January 2003 and October 2024, South Africa benefited from a total of 11 greenfield foreign direct investment (FDI) projects from Québec. These projects brought about a capital investment of ZAR1,951.25m and created 326 jobs. The transport, manufacturing and business services sectors were the recipients of most of the FDI projects during the period under review, which is shown in Table 5.

## 5. Tourism

#### 5.1 Passenger Arrivals from Québec in South Africa




Figure 5: Passenger arrivals from Québec in South Africa, 2019–2023

Figure 5 reflects the number of passengers from Québec arriving in South Africa during the period 2019 to 2023. In 2023, a total of 656 tourists arrived from Québec in South Africa, an increase of 86.36% y-o-y when compared to the same period in 2022.

#### 5.2 Passenger Arrivals from Montréal through Cape Town International Airport




Figure 6: Passenger arrivals from Québec through CTIA, 2019–2023

Figure 6 presents the number of passenger arrivals from Montreal in Québec into Cape Town via Cape Town International Airport (CTIA) from 2019 to 2023. In 2023, the CTIA welcomed 169 passengers from Québec, representing a 28.03% y-o-y growth compared to the 132 passenger arrivals in 2022.
